Good morning Mr O'Farrell,

I refer to the various correspondences I have sent to you regarding the circumcision of my son without my consent in 2010.

As you will recall, I have two issues.

1. That government still sees non-medically indicated infant circumcision as acceptable, despite an overwhelming lack of support in the community and
2. That my son was circumcised, for no medical reason, without my consent.

Regrettably, my written campaign to have the injustice suffered by my son and I recognised and to have appropriate changes to laws, policies and regulations made to protect parents and infants that find themselves in similar situations, has failed dismally.

The latest example of my failure can be seen in a reply received from Mr Greg Smith. Mr Smith advises me that he "*carefully reviewed the previous correspondence you attached*" but made no mention of my lack of consent to my son's circumcision.

On the 20<sup>th</sup> of March I posted a domain, [www.MyCircumcisionDisgrace.org](http://www.MyCircumcisionDisgrace.org). As of this morning it has received just over 5,000 unique visitors. The majority originate from overseas, predominately the United States and the United Kingdom. Nevertheless, over 500 Australians have taken the time to read my story.

In all, I have received nearly 300 emails from the site. Although I understand that statistically this is a very jaundiced sample pool, all but 6 people have expressed their absolute dismay. Many people required considerable persuasion in order to believe that my son could possibly have been circumcised without my consent.

Of the 6 people who were non-supportive, one assured me that my course of action will mean that I will spend eternity in a fiery hell for "*spitting in Gods [sic] face*". Naturally, I have made sure I have an adequate supply of asbestos underpants.

Constantly upgrading the bandwidth of the site has meant that I have not had funds to propagate the site using Google AdWords. This will be an important tool, as it will reach an audience who is not necessarily searching for a result based on the content of my site.

I remain of the view that you are one of a small number of people who are in a position to cause an immediate change to many of the regulatory shortcomings that culminated in the vandalism of my son's and my rights.

Accordingly, Mr O'Farrell, my first set of keywords, beginning next week, will be based around your name as well as the normal set of words to do with infant male circumcision.

This letter is a courtesy to apprise you of this fact.
